

This Privacy Policy Notice is being provided to you on behalf of High Knoll Wealth Advisors ("HKWA"). This notice has been prepared to describe to you what HKWA collects, handles, and safeguards your personal information.

**Why are you receiving this notice**? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What information do we collect? The types of personal information we collect and share depend on the service that we provide to you. This information can include, but would not be limited to (1) your social security number and income; (2) your address and date of birth; and (3) your account balances and transactions.

**How do we typically share your personal information**? Financial companies typically need to share a customers personal information internally in order to run their everyday business – to process transactions, maintain or service customer accounts, and report to credit bureaus. In the section below, we list the reasons many financial companies can share a customers personal information; the reasons we choose to share your information; and whether you can limit this sharing.

## Does High Knoll Wealth Advisors (HKWA) use any Third-Party Digital Platforms and Applications?

High Knoll Wealth Advisors (HKWA) may use third-party digital platforms or applications, such as phone apps or online portals, to facilitate account access, communication, or service delivery. These platforms may collect or process your personal information as part of their functionality. HKWA ensures that any third-party provider complies with applicable federal and state laws and maintains appropriate safeguards to protect your information. These providers are prohibited from using your information for purposes beyond those necessary to provide the agreed-upon services. How often does HKWA notify me about their practices?	We must notify you about our sharing practices when you engage our services and each year while you are a customer.
How does HKWA protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and offices.
How does HKWA collect my personal information?	<ul> <li>We collect nonpublic personal information about you from the following sources:</li> <li>Information we receive from you on applications or other forms;</li> <li>Information about your transactions with us, our affiliates, or others; and</li> <li>Information we receive from a consumer reporting agency.</li> </ul>
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit sharing only for <ul> <li>affiliates' everyday business purposes – information about your creditworthiness;</li> <li>affiliates to market to you; and</li> <li>non-affiliates to market to you.</li> </ul> </li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>
How does HKWA treat my personal information once I am no longer a customer?	The firm will provide nonpublic information about former customers only if required to do so by law or regulation or to those parties who need such information in order for the firm to carry out any continued obligation with respect to the services covered by the former adviser/customer relationship.
